#### **Lovely Lady Dressed in Blue**

It's 7 p.m. on a Sunday evening. The dishes are done and it's time for "Life is Worth Living." For those readers who grew up in the 1950s, reading the name of that show will strike a memory chord. It was almost a part of our Sunday religion to gather in front of the little black and white TV screen, even if the view was mostly wavy lines and the sound was distorted unless someone held the antenna just right. It was time to tune in to Fulton J. Sheen's "Life is Worth Living!"

Sheen would share tips for graceful living and his great devotion to our Blessed Mother. He'd sometimes tell his listeners if they were friends of Jesus' Mother when they reached the pearly gates they ought not be surprised to hear Christ say: "I've heard my Mother speak of you."



One of the rhyming prayers – along with the Guardian Angel Prayer – that became part of children's bedtime repertoire (and still sticks in this 80-year old brain) was Sheen's oft quoted "Lovely Lady Dressed in Blue."

Much of what we know about Mary is found in the Gospel by the Evange-

list Luke. That's where we learn about Mary's actions after the announcement of Jesus' birth by the angel Gabriel. It's that last line in the story that is striking ... (Then the angel departed from her.) What Mary did next kept the ball rolling. God, the director said "Action!" Mary eagerly goes dancing over the hills -well, maybe not quite "dancing" as the journey was 50-70 miles. How many noticed this young girl, unescorted, obviously destination-certain? Gasping for breath she bound into the home of her cousin, Elizabeth, eager to share her news. She needed someone else to hear what she'd been told. She stopped short when she saw Elizabeth's "baby bump." God was up to something big here! Elizabeth was way beyond her child-bearing years.

The story is quite simple: an encounter between two pregnant women (cousins), the first one is already experiencing the movement of the child in her womb. The baby moves, more than "moves" — the baby "LEAPS" when Mary calls out to Elizabeth. Maybe she says something like: "Elizabeth, wait till I tell you what happened to me the other day!" Many of you are mothers. Can't you see Elizabeth grabbing her middle — "Whew! that wasn't an ordinary kick — "my child just leaped!" Elizabeth is the "amazed saint." Her attitude is summarized in her question, "Why am I so favored?" Here is humble

amazement at being able to participate directly in God's plan. All who have a role in God's plan should share this wonder. Blessings emerge from God's ability to bring his promises to completion. In order to share those benefits, we must be confident, like Mary and Elizabeth, that God does what He says. The first sign of such faith in Mary was her willingness to let God use her.

Turn the pages ahead 30 years to Jesus' public ministry. Those years must have taken a great toll on Mary. When Jesus was still a babe in arms, Simeon had predicted that a sword of sorrow would pierce Mary's soul. One such occasion was when Jesus' relatives were convinced he was out of his mind. Not a very pleasant experience for any family, no matter how holy.

The saddest moment of all came when Mary watched her son die on the cross. What kept the family together and sane throughout all those trials and crosses? The answer is 'Love for each other and God' - Jesus' love for Mary and Mary's love for Jesus, and the love of both of them for God the Father.

Devotion to Mary is a heart-connection ... a non-threatening, she-understands-me sort of relationship. Stories of her miraculous appearances to people "just like us" fill us with awe and a desire for closeness to Mary. We marvel at the believer's relationship with Mary that naturally blends with their relationship with her Son, Jesus. We trust her motherly instincts. We plead with her to "hold open the back door of heaven" of us.

It's hard for an individual to explain in human words what a relationship with Mary means. It hard to imagine how Mary — a young teenage girl from a small village, must have felt when an angel appeared. Had angels come to her before, so she was not surprised or startled? I think it was her child-like faith, her reliance on God's presence in her life that made her wonder, but not fear.

During the upcoming Advent season — which is fast approaching - we'll experience what I'll call "factured attention." You know, it's like viewing life through a Kaleidoscope. It changes just when you think you've got a good focus. At this writing, we have high hopes for a COVID vaccine, but we plan like we may still be on high alert.

May God bless each of you, and your families and loved ones. Walk with Mary this Advent. Ponder with her what is happening in our world. Something **IS** happening. Let us, take Mary's hand and as the saying goes: "Go with the flow."

#### Our Lady of Fatima

My connection to the **Blessed Mother** has its roots early in life. My birthday and baptism are in May and my first Profession of Vows was made on the Feast Day of the Immaculate Conception of Mary.

Our Blessed Mother's first apparition at Fatima was in the month of May and her message highlights many central truths and devotions of my Catholic faith: the Holy Trinity, the Holy Eucharist, penance, repentance, the Holy Rosary, and sacrifices for the conversion of sinners. Her promise to assist at the hour of death with the graces necessary for salvation has always resonated deeply with me.

The highlighted devotions and practices are an integral part of my family's daily living. They were well imbued within me when I became a member of the Missionaries of Charity, founded by **St. Mother Theresa** of Calcutta who was greatly devoted to the Blessed Mother. In every convent of the Order, there is a grotto of Our Lady of Fatima. Each day after night prayer the Community sings a hymn of Mary.



May 13, 1917 was the day of the first Fatima apparition and on the very same day in 1981, Saint John Paul II survived an attempt on his

life in St. Peter's Square. John Paul credited his survival to the intervention of Our Lady of Fatima. The assassin's bullet that narrowly missed killing the pope now is inserted in a crown of Our Lady housed at the Fatima shrine.

Our Lady assured **Lucia**, (one of the children who witnessed Mary's appearance): "my Immaculate Heart will be your refuge and the way that will lead you to God."

#### A Case for Mary, Untier of Knots


In early July **Sister Roberta** handed me a letter from Sister Jerome's cardiologist explaining she would have to find another doctor. They would not schedule her because she did not have Part B Medicare.

With some research advice by an Advocate for the Elderly, I called and left messages with the cardiologist's staff, asking him to continue to care for **Sister Jerome** while we

worked on getting her back on Part B. In the meantime, I learned of a webpage that offers help with federal agencies, such as Medicare. First, a signed Privacy Act Consent Form was needed. Only Sister Jerome's signature would be accepted though Sister Roberta is her legal Health Care Surrogate.

Sister Jerome was in "Assisted Living" and the facility was in lockdown, allowing no visitors. I was able to speak with the Resident Care Coordinator who kindly took time out of her schedule to get Sister Jerome's signature and send it in. We received an automated email saying a case manager would contact us in a few days. We never heard from them despite my many calls and emails.

I called the Florida agency SHINE (Serving the Health Insurance Needs of Elders) and talked to one of their volunteers. He advised, "somebody has to get with her and call Social Security." There was no one at

We then tried a call to our congressional office. A live person answered assuring me that I would hear from someone in a few days. Weeks passed with no word. Then, very late on a Friday afternoon, we received a call from the Case Intake Manager. She was eager to help us, especially when she learned that Sister Jerome and Sister Roberta were Benedictine Sisters. She confided that she had once hoped to become a Maryknoll Sister. Yes, their Privacy Act Consent Form would be mailed and that they would accept Sister Roberta's signature.

With our conversation almost concluded, the case manager asked me for Sister Jerome's address. As I gave her the Tampa address, I began to have a sinking feeling. "She's not in your congressional district," were the next words I heard. "But we are," I replied weakly. "It all seems so hopeless," I added.

There was a long hesitation ... I think that was when the grace of Mary, Untier of Knots, came down upon us. The intake manager then said, "I'll have the case manager take care of it." Four days later we were notified by email that Sister Jerome's new Medicare card with Part B coverage was in the mail. Volunteer Dr. Kathleen Daye



#### THANKSGIVING OUTREACH 2020

For the first time in 26 years, the Benedictine Sisters of Florida were not able to hold our annual Thanksgiving Dinner. Covid eliminated that particular out-reach to those alone or unable to prepare the traditional meal of thanks. We were, however, thrilled to participate in a collaborative effort this year to provide Thanksgiving Baskets for those in need!

The Sisters began what has become a joyous ministry very small in the beginning, in their monastery dining room, to provide a holiday

meal for a handful of Saint Leo College International Students. Within three years the Sisters moved the event to Marmion Cafeteria and extended an invitation to the public to join them for dinner. They gathered a crew of volunteers that grew over the years. In 1998, the Sisters sold Marmion Cafeteria to Saint Leo and the Saint Anthony Women's Club jumped on the bandwagon and have continued for 16 years to provide all the desserts for the dinner. Saint Anthony School children also got involved by making table centerpieces and place mats.

When it became apparent that the dinner was not viable this year, a collaboration formed with First Presbyterian Church of Dade City, **Pastor Cheryl Duke. Father Ed Lamb** of Saint Mark's parish originated the basket idea. The Knights of Columbus from that parish jumped in with \$1,520 and gift cards and the Sisters donated \$1,305 from their monthly personal allowances! The Saint Leo University Social Service Club, faculty advisor **Dr. Veronika Ospina-Kammerer**, always raises funds for our Thanksgiving outreach and this year was no different. This project with many volunteers, the monetary donations, and supermarket gift cards extend our mission to "feed the hungers of the people of God."



We greatly missed the gathering this year and look forward to a future when we can once again welcome our guests to bow their heads over a holiday meal and give thanks to God for all the gifts He provides.


#### From the Advancement Office






Meaningful Christmas Gift Giving

#### CARES Act and a <u>NEW</u> Charitable Tax Deduction



The CARES Act signed into law on March 27, 2020 is an oppor-

tunity for taxpayers who do not itemize to receive a tax benefit when making a donation to charity.

**Non-itemizers** may deduct up to \$300 per taxpayer (\$600 for a married couple) in annual charitable contributions. This is particularly beneficial to people who take the standard deduction when filing their taxes (in other words for taxpayers who do not itemize their deductions).

<u>Calculating the deduction is easy!</u> The amount of the donation is subtracted from your gross income. The adjusted gross income (AGI) is reduced, and thereby reducing your taxable income. The contributions must be cash gifts to a public charity such as the Benedictine Sisters of Florida (cannot be made to a donor advised fund, certain supporting organizations or certain private foundations.)

Appreciated securities are another easy way to make a charitable gift for those whose stock market wins have set them up for the potential of high capital gains. When you transfer ownership of long-term holdings to charity, you receive a charitable deduction for their full market value—and you incur no capital gains tax (subject to IRS deduction limits).

NOTE: For those 70 and 1/2 you probably know that the IRS has suspended for 2020 your Required Minimum Distribution (RMD). Folks who are fortunate to have not needed their RMD, have donated it to charity in the past and received a tax deduction. Since the distribution from your retirement plan is not required in 2020, the new CARES Act law is worth considering in giving to charities close to your heart.
